Players Choice Volleyball Club PARTICIPATION AGREEMENT

Conditions of Participation for the 2022-2023 season

We, the parents/guardians of ______have read the club handbook information on the Club Web Site (playerschoicevolleyball.org) concerning the policies and practices of the Players Choice Volleyball Club, Director, and coaches (hereafter called PCVC). We agree, that having been selected to a team, to let my child join the club for the current season. PCVC offers volleyball training for its members.

We understand that we are responsible for all fees due as well as her transportation to all events. Maintaining membership on a specific team will be at the discretion of the director of the club.

We have read this material and understand the time commitment involved in participation of all events. We have reviewed the fee schedule and understand that all fees must be paid in full regardless of the duration of participation by the individual. Understanding the stipulations and having discussed these with our child, we agree to and will support her participation in the club. We understand that once registered with, and having competed with the club, the player will be unable to transfer clubs and compete in USAV regional and National Championships.

Players, Parents and spectators will be required to conduct themselves in a professional and exemplary manner at practices, scrimmages and tournaments. Every player is a club representative and is expected to be a diplomat of the club. Violations including official sanctions, warnings, game dismissals or disqualifications must be reviewed by the director and may be grounds for immediate dismissal.

I hereby authorize Players Choice Volleyball Club (PCVC) to publish the photographs taken of me and/or the undersigned minor children for use in the PCVC's printed publications and website. I release PCVC from any expectation of confidentiality for the undersigned minor children and myself and attest that I am the parent or legal guardian of the children listed below and that I have the authority to authorize PCVC to use their photographs and names. I acknowledge that since participation in publications and websites produced by PCVC is voluntary, neither the minor children nor I will receive financial compensation. I further agree that participation in any publication and website produced PCVC confers no rights of ownership whatsoever. I release PCVC, its directors, and coaches, from liability for any claims by me or any third party in connection with my participation or the participation of the undersigned minor children.

In addition to the general guidelines, PCVC has established the following participation guidelines for the current season, that may be updated as needed, in connection with voluntary participation in sanctioned events, practices and activities, these may change rapidly and unexpectedly, if uncertain, email us.

DO NOT ENTER THE FACILITY IF:

- If you are feeling ill in any capacity,
- If the player is currently under a school quarantine,
- You or someone in your direct contact has been diagnosed or believes they may have COVID-19
- If you or someone in your home has had a fever in excess of 100.4 in the past ten days

Until COVID-19 is either eradicated, or contained through wide-spread vaccination and/or therapeutics, there is no way to completely eliminate the risk of infection and as such PCVC strongly encourages all participants to follow these recommendations as safety precautions. The information in this document is not intended or implied to be a substitute for professional medical advice, diagnosis, or treatment, nor does PCVC assume any liability or responsibility for the recommendations provided herein.

Participation in the scheduled events is strictly voluntary. No one is forced or required by anyone to participate. Participation in or attendance by anyone in PCVC scheduled events is strictly voluntary and AT YOUR OWN RISK.

By indicating my acceptance, I acknowledge the following: I agree to indemnify and hold harmless, PCVC, the club and site/facility used for practices and/or tournaments, and any other unnamed organization associated with the events, programs, and activities, as well as their employees, agents, and representatives working to organize and operate the event/program, from liability due to COVID 19 or related diseases. I understand that if I choose NOT to accept the liability and risk inherent with participation/attendance, myself and/or my family members will not be able to participate or attend an event.

I WAIVE, RELEASE, AND DISCHARGE from any and all claims or liabilities for death or personal injury or damages of any kind, except that which is the result of gross negligence and/or wanton misconduct of PCVC and each site/facility which arise out of or relate to my traveling to and from or my participation in any volleyball event, I INDEMNIFY AND HOLD HARMLESS the coaches, directors and PCVC from any claims made or liabilities assessed against them as a result of participation activities.
